Laboratory, pharmacy ^{7(b)} morgue and facilities to doctors, ^{8(c)} nurses and supporting staff. However, unfortunately ~~said~~ hospital building has not been put to use for public service.
We understand that new hospital premises is constructed to be linked with Goa Medical College as one of the condition of the medical council of India while granting 150 MBBS seats from existing 100 seats in Goa medical college. Recently Goa medical college MBBS seats further increased by to 200 by grant issued by National Medical Commission. In both this cases ~~said~~ area hospital under college remains as per clause 1.19 of regulation in force.
To demand immediate functioning of hospital, ~~town~~ hospital ~~committee~~ formed and the delegation of committee along with hon'ble MLA Shri. Jit Arelkar met hon'ble chief minister of Goa Dr. Pramod Sawant on 6th of August 2024. During the discussion hon'ble chief minister informed delegation of the committee that the existing community health center services managed by Directorate of Health Services (DHS) will be shifted in new building and slowly other facilities will be made available in the hospital in future. It was also informed that experienced doctors in Surgery and Anaesthesia are reluctant to join DHS. The Delegation of committee did not accept the proposal of hon'ble chief minister, but insisted to start hospital as planned with all the facilities and managed by GMC.

Secondly, Nowhere in Goa and even in rest of India such a huge complex with various facilities, constructed for community health centre, hon'ble minister for health is saying that such a huge size of building and facilities, definitely not for the community health centre.

Therefore, after going through the above discussion, we strongly object the decision of shifting existing community health center facilities in new building of 100 beds hospital.

We further demand that the 100 beds hospital with all the facilities as planned be put to public service under Goa medical college (GMC)

After deliberation and discussion on above matter, the members present for the meeting has unanimously decided to forward the resolution to hon'ble chief minister of Goa, hon'ble Health minister and the Director, Directorate of health services, Panyal Goa for implementation.




